


Dear Colleague,

Dear Pete:

Pursuant to the authority delegated to me as Chairman of the Committee on Rules and Administration, and confirming arrangements made, you are hereby granted permission to reserve the Russell rotunda for a photo exhibit of Mono Lake in California from June 4th through June 8, 1984.

Changes in security policy require this Committee to establish new procedures for granting permission to use the Russell rotunda for exhibits. Listed below are the guidelines:

1. No exhibits may be displayed in the rotunda for more than five days.
2. Political exhibits are prohibited.
3. All exhibits should be on mounted displays. The Office of the Senate Superintendent can provide easels if needed. Exhibits are to be kept simple to avoid clutter and access problems through the rotunda by staff and visitors. Photos or paintings cannot be hung from the pillars or walls.
